Subject: Presentation meeting on Online Vigilance Status of below Board Level Executives of CPSEs - Inviting CVOs of CPSEs

As you are aware Secretary, DOPT had, vide d.o. letter of even number dated 19.1.2017, informed that NIC-DOPT is developing a web portal for maintaining the data on vigilance status/profile of Board and below board level executives of CPSEs. Now the Web portal is ready for implementation.

2. The web portal was presented before the Central Vigilance Commission. It has been decided that the CVOs of Ministries/Departments will be responsible for feeding the data pertaining to the board level executives of CPSEs and the CVOs of the CPSEs will be responsible for feeding the data pertaining to the below board level executives.

3. A meeting was held under the chairmanship of Secretary-DOPT on 16.2.2017 with the CVOs of the Ministries/Departments wherein NIC-DOPT made a presentation of the online portal being developed for providing online vigilance status of Board Level Executives of CPSEs, banks, financial institutions, etc.

4. On the same lines, a meeting is scheduled to be held on **22.2.2017 and 23.2.2017 at 3.00 PM in the Civil Services Officers Institute(CSOI), Vinay Marg, New Delhi**, as per the schedule attached, wherein NIC-DOPT will make a presentation of the online portal developed for providing online vigilance status of **below Board Level Executives of CPSEs**. Any issues likely to arise when the online system is implemented and data is uploaded on the portal by the concerned CVOs would also be addressed.

5. It is requested that the CEOs of the CPSEs under your administrative control may be directed to depute the **Chief Vigilance Officers of the CPSEs, etsc and one officer below them** who are responsible for maintaining vigilance related data of below Board Level Executives of CPSEs to attend this sensitization session on the scheduled date and time.
