

IMPORTANT DEVELOPMENTS WITH REGARD TO
DEPARTMENT OF PERSONNEL & TRAINING FOR THE
MONTH OF OCTOBER, 2016

1. Hon'ble Prime Minister addressed the Valedictory Session of the Assistant Secretaries (IAS-2014 batch) at DRDO Auditorium, New Delhi on 27th October, 2016. During the Valedictory session, eight (8) Assistant Secretaries made presentations before Hon'ble PM.
2. Hon'ble MoS (PP) launched the Employees Online (EO) Mobile App of DoP&T on 28th October, 2016 to enable its users, which may include officers, media persons and all stakeholders to stay updated on real time basis with appointments and postings approved by the Appointments Committee of the Cabinet (ACC) and vacancies at senior level in the Government of India. This is an effective management tool which also empowers the IAS Officers on Pan India basis and Officers serving under Central Staffing Scheme by providing their personal records like Annual Performance Appraisal Report (APAR), Immovable Property Return (IPR), Executive Record(ER) sheet through secured NIC login Id and Password.
3. DoP&T organized a feedback-cum-interactive session of the Assistant Secretaries (IAS Officers of 2014 batch) with senior officers of various Ministries/Departments on 21.10.2016 at CSOI, New Delhi.
4. Blood Donation Camp was organised by DOP&T in association with the Indian Red Cross Society, New Delhi at Shastri Bhawan, New Delhi on 24.10.2016 and 32 employees donated blood in this camp.
5. 2 Director/ Deputy Secretary and 7 Under Secretary Posts are encadred in Central Secretariat Service (CSS) cadre of Ministry of Social Justice and Empowerment.
6. 4 Posts of Director are encadred in CSS in Central Vigilance Commission.
7. The tenure of the Advisory Committee of State Cadre employees (other than AIS), between the successor States of Andhra Pradesh and Telangana, under the Chairmanship of Shri. C.R. Kamalanathan has been extended for a further period of 4 months i.e. upto 31st December, 2016. The Advisory Committee has examined cadre strength of all the 90 Departments, identified for allocation of post and personnel, in consultation with the concerned HoDs and accordingly, tentative allocation has been published in respect of 90 Departments calling for objections/ representations. The recommendations of the Advisory Committee have been received in the DoPT in respect of 89 HoDs and Final Allocation orders have been issued in respect of 88 Departments.

8. The proposal of SSC for conducting examination for recruitment to 502 vacancies in the post of Scientific Assistant in India Meteorological Department was approved vide letter No.39020/04/2016-Estt(B) dated 25.10.2016.
9. Central Secretariat Swimming team won the Championship in All India Civil Services Swimming Tournament which was held at Gandhinagar, Gujrat from 18th to 20th October, 2016.
10. Sports meet for Assistant Secretaries of 2014 batch IAS Officers was organized by CCSCSB on 15th & 16th October, 2016 at SIRI FORT SPORTS COMPLEX, New Delhi.
11. 22 Training programmes including 04 Central Secretariat Service (CSS)/ Central Secretariat Stenographer Service (CSSS) CTP programmes were conducted at ISTM. The number of participants in these programmes was 635.
12. Appointment's committee of the Cabinet (ACC) has approved appointment of 02 CMD/MD and 04 Functional Directors in various Schedule A & B Central Public Sector Enterprises (CPSEs). Further, One (01) proposals of Extensions, One(01) proposals of Appointment of PS to Minister, Two (02) proposals of Appointment of OSD to Ministers has been approved by the Cabinet Secretary/ACC.
13. Standing Committee Meeting was held on 25.10.2016 with the representatives of Staff Side, National Council (JCM) under my Chairmanship to discuss various issues pertaining to Staff Side. On the same day, I also held another meeting with the representatives of Staff Side, National Council (JCM) on issues relating to the DoP&T-Specific Allowances.
14. Presentations on the structure and function of this Department, Central Vigilance Commission (CVC) and Central Bureau of Investigation (CBI) were made on 04.10.2016, before Department related Parliamentary Standing Committee.
