Dear Madam/Sir,

The 17th round of Phase-III training of the Mid-Career Training Programme (MCTP), 2021 for IAS officers has been scheduled from 22nd February to 19th March, 2021 at the Lal Bahadur Shastri National Academy of Administration, Mussoorie. This round is being offered to the following officers:

- (v) Officers of 2013 batch (1st chance)
- (vi) Officers of 2012batch (2nd chance)
- (vii) Officers of 2011 batch (3rd and last chance)
- (viii) Officers of 2006 to 2010 batch (on case to case basis)

2. Further, an officer who has less than three years of service after the year in which he/she has been slotted to undergo the Phase-III of the MCTP would not be deputed for the training and, therefore, the officers retiring before 31.12.2024 need not be nominated for the proposed Phase III programme.

3. A list of the officers falling in the eligibility zone (i.e. after deleting the names of the officers who are superannuating before 31st December, 2024), as per available database, is attached. I would get this database updated, in case any discrepancy is brought to DoP&T's attention.

4. I would like to add that all phases of the MCTP are mandatory and entail advance planning in terms of tying up with foreign/domestic partner institutions and faculty resources, apart from setting up the logistics required. As per the IAS (Pay) Rules, 2016, undergoing Phase III, MCTP is a pre-requisite for appointment to the Junior Administrative Grade. A copy of the letter dated 01.02.2012 from Secretary (Personnel) to all Cadre Controlling Authorities, indicating the relevant provisions of the IAS (Pay) Rules, is enclosed for ready reference.
