- 2. Now, with a view to re-constitute the Departmental Council of DOP&T, action for fresh nomination of members of staff side of the recognised Associations/Unions is under way. Besides, it is also observed that Office Councils in various Ministries/Departments of Central Secretariat have not been functioning for a long time. Therefore, all the above six Associations/Unions are eligible for conducting the elections for constituting the office Councils in various Ministries /Departments of Central Secretariat.
- 3. Besides, references have been received from the Associations/Unions that some DDOs are not deducting the subscription of employees and crediting them in favour of the concerned Association/Union for the year 2008-09. In this connection, attention is invited to this Departments' O.M. No 2/10/80-JCA dated 31<sup>st</sup> January, 1994 which stipulates that consent for deduction of annual subscription shall remain valid till altered or withdrawn. The option for deduction, if any, can be exercised only in the month of April each year to be effective from July of that year. Further, recoveries of annual

subscription from pay roll in favour of the Associations/Unions shall be made every year by the DDOs as per provision made under CCS(RSA)Rules,1993.

4. All the Cadre Controlling Authorities / DDOs are once again requested to take action accordingly and give their support to concerned Association/Union for discharging their functions towards the Service Association for conducting election, constitution of Office Councils and related matters.
