The undersigned is directed to refer to this Department's O.M. No. 11/1/2021-CS.II(B) dated | 2.01.2021 on the subject mentioned above and to say that with the approval of competent authority, it has been decided that the period of ad-hoc appointment of the Senior Secretariat Assistants of CSCS who are working as Assistant Section Officer of CSS on ad-hoc basis may be extended further upto 31.12.2021 or till further orders, whichever is earlier.

- 2. Continuance of ad-hoc appointment shall not confer on the appointees any right to continue to the grade of Assistant Section Officer indefinitely or for inclusion in the Select List of Assistant Section Officer of CSS or to claim seniority in the grade of Assistant Section Officer of CSS.

 - (ii) The SLP(C) No.30621/2011 arising out of the final judgment and order dated 15.07.2011 in WP(C) No.13218/2009 passed by the Hon'ble Court of Punjab & Haryana and other connected cases before the Hon'ble Supreme Court;
 - (iii) The SLP (C) No.31288/2017 arising out of the Hon'ble Delhi High Court judgment dated 23.08.2017 in WP(C) No.3490/2010 filed by the All India Equality Forum & Ors. Vs UOI & Ors. And other related court cases in any competent court;
 - (iv) Any other court cases in connected matter.
