This is regarding posting of IAS officers of 2019 batch with the Central Government, as Assistant Secretaries, on completion of their Phase-II training for a period of 3 months from 28.06.2021.

2. The scheme of posting the IAS officers as Assistant Secretaries with the Central Government was initially launched for the 2013 batch and has continued thereafter except for the 2018 batch. 4. I shall be grateful for an early consent from your end preferably by 15th March 2021, so as to efficiently organise the programme in various Ministries/Departments.


