- 2. The appointment of these officers as Director will be effective from the date of assumption of charge of the post.
- 3. The seniority of these officers included in the afore-mentioned Select Lists is indicated in column (f) of the table under para 1 above, irrespective of actual dates of their appointment to the Senior Selection Grade.
- 4. In terms of Rule 2(c)(iii) of CSS Rules, approved service in the grade of Director will count from 1st July of the respective Select List Year.
- 5. In terms of CSS Regulations, 2010, an eligible officer for inclusion in SSGSL should have successfully undergone such mandatory training programme as may be prescribed under Cadre Training Plan of DoPT. In terms of CSS (CTP), successful completion of Level F Training is mandatory for inclusion in SSGSL.
- 5.1 However, the Competent Authority has approved under Rule 23 of CSS Rules, 2009, in consultation with UPSC, grant of one time relaxation in the provisions of completion of mandatory Level-F training for appointment as Directors on inclusion in Select List from Select List Year 2018 onwards up to the Select List year 2022, subject to the condition that the officers included in the aforementioned Select Lists, are required to successfully complete the Level-F training after promotion, as per the nominations made by the DoP&T.

- The Ministries/ Departments, before issuing necessary notification, shall ensure that the officer(s) concerned is/are clear from vigilance angle in terms of DoPT O.M. No. 22034/4/2012-Estt (D) dated 2.11.2012 read with O.M. No. 22011/4/91-Estt(A) dated 14.9.1992 and O.M. No. 22012/1/99-Estt(D) dated 25.10.2004. In case of any change in the vigilance status of the officer from the last report, the same may be communicated to AVD.I and CS.I Division of this Department immediately.
- In case of currency of any penalty imposed on an officer included in the Select List, notification should be issued only after the currency of the penalty is over in terms of DoPT's O.M. No.22034/5/2004-Estt(D) dated 15.12.2004. Such cases should be informed to this Department separately.
- 7. The inclusion of officers in SSGSL will remain subject to further orders of the Hon'ble Supreme Court of India in the Civil Appeal No. 629 of 2022 arising out of SLP(C) No. 30621/2011 titled Shri Jarnail Singh & Ors. V. Lachhmi Narain Gupta & Ors. and other connected matters.
- 8. The copy of notifications for regular appointment of officers should invariably be endorsed to this Department for record. In case any of the officers included in the Select List cannot be appointed to the Grade of Director on regular basis, the same may be brought to the notice of this Department immediately along with the reasons.
