**CIRCULAR**

**Sub : Inter-Ministry Swimming Tournament 2024-25.**

Central Civil Services Cultural and Sports Board (CCSCSB) is organizing Inter-Ministry Swimming Tournament 2024-25 on 20<sup>th</sup> August and 21<sup>st</sup> August, 2024 at Shyama Prasad Mukherjee Swimming Pool Complex (Talkatora Swimming Pool), Mother Teresa Crescent Road, New Delhi. The Ministry/ Department desirous to participate in the tournament may send their entries in the prescribed proforma (**Annexure-I**) along with the entry fee and photocopy of Identity Card of all the players. The entry fee for the Single Event is Rs.200/- and for Team/Relay Championship is Rs.600/. Last date for submission of entries in the office of Central Civil Services Cultural & Sports Board office, Room No 361, 'B' Wing, Lok Nayak Bhavan, Khan Market, New Delhi - 110003 is **16<sup>th</sup> August, 2024.**

2. There will be only one team from each Ministry. The Ministry may include in their team persons working in the attached and subordinate offices located at Delhi/ New Delhi. All teams/ Individuals would be represented as a part of Ministry's Team only. Central government autonomous organization like UPSC, Election Commission, C&AG's Office, Lok Sabha Secretariat, Rajya Sabha Secretariat, Cabinet Secretariat, PMO etc. can sent their independent teams. The entries are to be sent through the Welfare Officers of the Ministry/Department concerned.

3. The following categories of employees are not eligible for participation in this competition:-

- (a) Uniformed personnel in Defence Services/Para Military Organisations/ Central Police Organisation/Police/RPF/CISF/BSF/ITBP/NSG etc.
- (b) Employees of Autonomous bodies/Undertakings/Public Sector Banks/Corporations even though administratively controlled by the Central Ministries.
- (c) Casual/Daily wages workers.
- (d) Employees attached to offices on temporary duty.

In case, at any time, it is found that a player included in the team is not eligible, the team would stand automatically disqualified from the tournament.

4. No entry will be accepted unless accompanied with fee. The entry should be sent in the prescribed proforma (**Annexure I**) duly signed by the Welfare Officer concerned and should reach on or before the last date i.e. 16<sup>th</sup> August, 2024.


The entry fee should be deposited online in the CCSCSB account after entering the following details or at the given QR code: -

5. An individual cannot take part in more than three individual's events. Competition will not be held where less than 4(four) entries are received both in team and individual event. In case, at any time, it is found that a player included in the team is not eligible, the team would stand automatically be disqualified from the tournament.
6. Referees'/Umpires' decision shall be final and binding on the competing teams.
7. Any information regarding change in dates/venue/cancellation etc. about the Tournament will be available on our website i.e. [www.dopt.gov.in](http://www.dopt.gov.in). All participants teams are, therefore, requested to check the details of the tournament about any possible change.

- iii) Competition will not be held where less than 04 (four) entries are received both in Team and individual events.
- iv) Participation / merit will be issued at later date to be decided by the Sports Board.
- v) Uniformed Services/Police/Para-Military Personnel are not eligible to participate. Ministries/Departments have to keep in view the above said instructions while forwarding the entry of their Ministries/Departments in the tournament. In case, at any stage, if it is found that a player included in the team is not eligible, the team could stand automatically disqualified for the tournament.
