Sub: Long Term Domestic Programme: Inviting proposals from training institutes for LTDP during 2025-26.

Sir/Ma'am,

The Department of Personnel and Training, Training Division, Conducts Long Term Domestic Programme on Physical/Hybrid mode for officers of All India Services, Central Services—organized & non-organized, technical & non-technical, faculty members of State Administrative Training Institutes and also for officers of the State Civil Services (SCS) &Non-State Civil Services (Non-SCS).

2. This Department is exploring collaboration with potential partner institutes for conducting Long Term Domestic Programme on Hybrid (preferred) or Physical Mode of duration 1 year for the year 2025-26 in diverse and broad thematic areas as under:-

- 1. Public Policy,
- 2. Strategic Leadership/Negotiation/Communication & Decision Making,
- 3. Senior Management Program,
- 4. Development Economics,
- 5. Public Health,
- 6. Urban Development/Urban Governance
- 7. International Development
- 8. Data Analytics for Public Policy
- 9. Evidence for Public Policy
- 10. Public Administration/Public Management
- 11. Public Finance
- 12. Digital Transformation
- 13. Natural Resource Management etc.

3. The following points have been proposed in respect of LTDP programs for the upcoming calendar year 2025-26:-

- i. **Institutional Partnerships**: DoPT is now seeking fresh collaborations with topranked (below QS 500 ranking, Top 20 NIRF Ranking) institutions to ensure highquality education and international standards in program delivery.
- ii. **Learning Model**: The preferred format for these programs is a blended model, where most of the learning happens online/on weekends, and there are a few fixed campus

visits during the program duration making the program more accessible while maintaining quality.

- iii. **Thematic Focus**: The focus areas for these long-term programs include public policy, public management, public health, and economics. DoPT has identified the above 13 themes for the long-term domestic training programs and is open to proposals from eligible institutions.
- iv. **Standardization**: Uniform course duration and program hours across institutions will ensure consistency in training delivery and outcomes. Training institutions shall share details of their existing blended long-term domestic training programs to help establish a minimum basic structure and duration for the programs.
- v. **Technical Integration**: DoPT emphasizes the need for the training institutions to integrate their learning management systems with the iGOT Karmayogi platform, to ensure seamless tracking of the competency development of the participating officers.
- vi. **Long-term Commitment**: DoPT is also looking to enter into long-term (5-year) MoUs with the partner institutions to provide stability and protect the financial interests of both parties.

4. The institutes are hereby requested to furnish their proposals for conducting Long Term Domestic Programme for the year 2025-26 on the aforementioned areas along with its indicative cost (exclusive of taxes, which may be mentioned separately). Relevant programme brochures, if any, may also be shared with this Department. Existing partners shall furnish full justification for any cost escalation over the previous year.

5. It is also informed that if approved to collaborate, the institute shall be free to include other participants (not sponsored by the Government).
