The last date for receipt of applications/nominations of eligible and interested candidates, complete in all respects in the prescribed proforma, has now been extended till Friday, the 13th October, 2023 (5:00 pm). Applications/Nominations are invited by the Search Committee, Lokpal for preparation of a panel of names to be placed for the consideration of the Selection Committee for appointment as Chairperson and Members of the Lokpal.

- 2. Any person can make a nomination in respect of another person. However, such nominations shall be restricted to one name only for each position. Multiple nominations by the same person, for the same positions hall not be entertained and only the first nomination for the position received will be considered to be valid.
- 3. It shall not be permissible for the person nominating a candidate to withdraw his nomination and the nomination so made shall be treated as final.
- 4. The applications/nominations are being invited in terms of relevant provisions of the Lokpal and Lokayuktas Act, 2013 [hereinafter referred to as the Lokpal Act] and the Search Committee (Constitution, Terms and Conditions of Appointment of Members and the Manner of Selection of Panel of Names for appointment of Chairperson and Members of Lokpal) Rules, 2014, [hereinafter referred to as the Search Committee Rules].

The said statutory provisions can be accessed through the website of the Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training i.e. https://dopt.gov.in under the link"Lokpal".

5. In terms of provisions contained in section 3 of the Lokpal Act, the body of the Lokpal shall consist of a Chairperson and not morethan eight (8) Members of whom not less than fifty per centshall be Judicial Members.

6. ELIGIBILITY CRITERIA

(a) For appointment as Chairperson, Lokpal[please see sections 3(2)(a)& 3(3)(b) of the Lokpal Act]

Any person**who** –

- > is or has been a Chief Justice of India; or
- > is or has been a Judge of the Supreme Court; or
- > an eminent personi.e. if he is a person of impeccable integrityandoutstanding ability having special knowledge and expertise of not less than twenty-five years in the matters relating to
 - i. Anti-corruption policy;
 - ii. Public administration;
 - iii. **Vigilance**;
 - iv. Financeincluding insurance and banking;
 - v. Law&Management.
- (b) **For appointment as Judicial Member, Lokpal**[please see section 3(3)(a) of the Lokpal Act]

Any person **who** –

- > is or has been a Judge of the Supreme Court; or
- > is or has been a Chief Justice of a High Court.
- (c) For appointment as a Member other than Judicial Member, Lokpal [please see section 3(3)(b) of the Lokpal Act]

Any person of impeccable integrityandoutstanding abilityand having special knowledge and expertise of not less than twenty-five years in the matters relating to –

- i. Anti-corruption policy;
- ii. Public administration;
- iii. **Vigilance**:
- iv. **Finance**including insurance and banking;
- v. Law&Management.

NOTE: Not less than fifty per cent of the Members of the Lokpal shall be from amongst the persons belonging to the Scheduled Castes, the

Scheduled Tribes, Other Backward Classes, Minorities and women.[please see proviso under section 3(2)of the Lokpal Act]

7. AGE

Applicant/the person nominated shall not be**less than forty-five years of age**, on the date of assuming office as the Chairperson or Member, as the case may be; [please see section 3(4)(iii) of the Lokpal Act]

8. TENURE[please see section 6 of the Lokpal Act]:

The Chairperson and every Member shall hold office as such for a term of **five years** from the date on which he/she enters upon his/her office or until he/she attains the age of seventy years, whichever is earlier.

- **9.** OTHER PRE-CONDITIONS REQUIRED TO BE SATISFIED[please see section 3(4)(ii), (v) of the Lokpal Act]
 - (a) Applicant/ the person nominatedshall not be -
 - (i) a person **convicted of any offence** involving moral turpitude;
 - (ii) a person who has been removed or dismissed from the service of the Union or a State
 - (iii) affiliated with any political party
 - (b) The Chairperson or a Member shall not [please see section 3(4) of the Lokpal Act]
 - i. **bea member of Parliament;**or
 - ii. **be**a **member of the Legislature** of any State or Union territory;or
 - iii. bea member of any Panchayat or Municipality;

and

- iv. **hold any office of trust or profit** (other than his office as the Chairperson or a Member);
- v. carry on any business;
- vi. practise any profession,

and accordingly, before he enters upon the office of Chairperson or a Member, as the case may be, **shall, if**-

- (a) he holds any office of trust or profit, resign from such office, or
- (b) he is carrying on any business, sever his connection with the conduct and management of such business; or
- (c) he is practising any profession, cease to practise such profession".

10. SELECTION PROCEDURE:

The selection procedure and process shall be regulated in terms of the provisions of section 4 of the Lokpal Act, 2013 and the Search CommitteeRules, 2014.

11. SALARY AND ALLOWANCES[please see section 7 of the Lokpal Act]:

The salary, allowances and other conditions of service of –

- (i) the Chairperson shall be the same as those of the Chief Justice of India,
- (ii) other Members shall be the same as those of a Judge of the Supreme Court.

Provided that if the Chairperson or a Member is, at the time of his appointment, in receipt of pension (other than disability pension) in respect of any previous service under the Government of India, or under the Government of a State, his salary in respect of service as the Chairperson or, as the case may be, as a Member, be reduced –

- (a) by the amount of that pension; and
- (b) if he has, before such appointment, received, in lieu of a portion of the pension due to him in respect of such previous service, the commuted value thereof, by the amount of that portion of the pension.

Provided further that the salary, allowances and pension payable to, and other conditions of service of the Chairperson or a Member shall not be varied to his disadvantage after his appointment.

12. Other relevant information

Attention is invited to the provisions of section 8 of the Lokpal Act, whichpreventtheChairperson or Member of the Lokpal, after demitting office, from-

Reappointment as the Chairperson or a Member of the Lokpal;

- Any diplomatic assignment, appointment as administrator of a Union territory and such other assignment or appointment which is required by law to be made by the President by warrant under his hand and seal;
- Further employment to any other office of profit under the Government of India or the Government of a State;
- ➤ Contesting any election of President or Member of either House of Parliament or Member of either House of a State Legislature or Municipality or Panchayat within a period of five years from the date of relinquishing the post.

The applicant or person making a nominationmay kindly bear in mind the above statutory conditions at the time of making application or nominating any person in response to the advertisement for the post of Chairperson/ Member of the Lokpal.

13. HOW TO APPLY/MAKE NOMINATIONS

The applications or nominations may be sent by post addressed to the Chairperson, Search Committee for appointment as Chairperson and/or Member, **Post Box No. 12 GPO, New Delhi-110001**.

All applications or nominations must be made in the prescribed proforma, which can be downloaded from the website of the Department of Personnel and Training (https://dopt.gov.in) under the link "Lokpal".

Applications or nominations which are not in the prescribed proformaor are incomplete in any respect will be summarily rejected.

Earlier, the application/nominations, complete in all respects were to be submitted by 5:00 pm on 28th September, 2023. It has now been decided to extend the last date for receipt of applications/nominations to 5:00 pm on 13th October, 2023. Those who have applied earlier, need not reply again. Applications/ Nominations received after the stipulated timeline will not be considered.
