

**IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF
PERSONNEL & TRAINING FOR THE MONTH OF MAY, 2024**

I. Summary of Selections and Appointments:

- i. Advertisements for 09 (Nine) posts [02 (Two) for the post of CMD/MD and 07 (Seven) for the post of Directors] were issued by PESB, DoPT.
- ii. 08 (Seven) selection meetings [01 (One) for CMD and 07 (Seven) meetings for Directors] were held.
- iii. 05 Post of Secretary, 05 Posts of Joint Secretary and 11 posts of DS/Director have been filled under central Staffing Scheme. Presently, 16 posts of Additional Secretary, 31 posts of Joint Secretary and 57 posts at the level of DS/Director are lying vacant under Central Staffing Scheme.
- iv. Appointments Committee of the Cabinet (ACC) approved appointments in 08 cases (i.e. CMD/MD/CEO/Functional Directors/Director General Manager/General Managers) in various Schedule A & B CPSEs /Railway Board.
- v. Appointments of 07 Chairpersons/Members in various Tribunals/Statutory Bodies/Authorities/Commissions and 03 appointments of Chief Executives/Directors in Autonomous Bodies/Institutes have been approved by ACC.
- vi. Cabinet Secretary/ACC approved the following proposals (DS/Director level):

- vii. Proposal for appointment of 03 CVOs (01 Director level and 02 JS level) and extension of tenure of 02 CVOs at JS level were also approved.

II. Establishment Matters

- (a) Under Lateral Entry Cycle 2023-24, 25 officers were approved for appointment to the posts of JS/Dir/DS on contract/deputation, out of which 24 officers have joined their posts. Induction training was imparted to these officers during 13-27 May 2024 at IIPA, New Delhi.

- (b) Notification dated 31.05.2024 was issued regarding appointment of Shri Pradeep Singh Kharola, IAS (KN:85) (Retd.), as Chairman, Staff Selection Commission, with effect from the forenoon of 01.05.2024 till the appointment of regular incumbent or until further orders, whichever is earlier.
- (c) Timelines for recording of APARs in respect of Central Civil Services for the year 2023-24 has been extended vide OM dated 28.05.2024.
- (d) Review of SGSL of CSS officers (DS Grade) for the year 2013-2022 has been done.
- (e) Review of USSL 2012 for CSS officers has been completed and revised USSL 2012 issued as been issued vide OM dated 10.05.2024.
- (f) Staff Selection Commission (SSC) declared following results during the month-
 - i. Result of Paper 1 of Junior Secretariat Assistant/Lower Division Clerk Grade Limited Departmental Competitive Examination, 2019 & 2020 has been declared. 335 candidates (163- for the year 2019, and 172 for the year 2020) have been shortlisted for the next stage of the examination i.e. Part-II (evaluation of record of service).

III. Vigilance and other related matters

- i. Vigilance clearance of **170 (One Hundred Seventy) IAS officers** issued for various purposes viz. appointments, inter-cadre deputation, transfer, probation, ex-India-study leave etc.
- ii. Vigilance clearance of **13 (Thirteen) IAS officers** of 1991 batch for empanelment at Secretary level posts, **22 (Twenty Two) IAS officers** of 1996-1999 batch for empanelment at Additional Secretary level posts and **13 (Thirteen) IAS officers** of 2001-2008 batches has been issued for empanelment at Joint Secretary level posts at the Centre.

IV. Training and Capacity Building

(a) Institute of Secretariat Training & Management (ISTM)

- i. The Institute of Secretariat Training and Management (ISTM) conducted 09 Online/Offline Calendar Training Programmes, 01 Non-calendar course (Outside ISTM) and 04 CSS/CSSS Cadre Training Programmes. A total of 609 candidates participated in various Training Programmes.
- ii. ASODR-304, ASODR-305 Batch of ASO(DR) consisting of 110 ASOs were attached to Bharat Darshan & NGO exposure.

- iii. ISTM organized Sports Meet for ASOs DR 2022 Batch on 10.05.2024 in which total 9 events were conducted for Outdoor and Indoor games.
- iv. Blood donation Camp and essay competition were organized by ISTM on 17.05.2024 for ASO(DR) 2022 batch, in which all the participants were encouraged for actively participation.

(b) Assistant Secretary Programme, 2024:

- i. The Inaugural Session of the programme was held on 20.05.2024 under the chairmanship of Principal Secretary to Prime Minister, wherein all Assistant Secretaries and Nodal Officers of 46 Ministries/Departments were also present. Principal Secretary to Prime Minister interacted with the Assistant Secretaries. The Inaugural Session was followed by Orientation Session for Assistant Secretaries with faculties of LBSNAA and DoPT/ISTM.
- ii. A visit to the New Parliament House was organised for the Assistant Secretaries on 30.05.2024.

(c) Capacity Building Commission (CBC)

Immersion Visit: An Industry Immersion event at the Department of Pharmaceuticals took place on May 17, 2024. Officials from the pharmaceutical sector visited medical device companies. This event was organized in collaboration with CBC, the Department of Pharmaceuticals.

Consultative Workshop: On 28th May, a Consultative workshop was organized with IC- Center for Governance for Course on Ethics and Governance.

Courses: A course on TDS was finalized and uploaded on iGoT.

Collaboration with Urban Local Bodies (ULBs): CBC, in collaboration with iGOT, onboarded 26 ULBs from Gujarat on iGOT platform as well instituted a CBU head and an iGOT MDO Admin in each of them.

Citizen Centricity Toolkit: Pilot discussion on testing the tool in M/o Social Justice and Empowerment with Secretary MoSJE was held on 6th May. The tool was tested on two programmes -AVYAY NASHA MUKT BHARAT and NVCFDC with the support of the Joint Secretaries and Programme Heads.

Quality Improvement Plan (QIP): Quality Improvement Plan (QIP) kick-off meeting conducted with National Academy of Direct Taxes (NADT), Nagpur on 6th May 2024 and Yantra Institute of Technology and Management, Nagpur on 29th May 2024.

Onsite visit for discussion on the QIP draft, with NADT QIP Taskforce, conducted on 28th May 2024.

(d) Karmayogi Bharat (SPV)

- i. Karmayogi Bharat and MyGov conducted a co-learning session on 16th May, 2024, to discuss best practices in the area of government communication.
- ii. On 17th May, 2024, Karmayogi Prarambh for Lateral Entrants, a curated program offered by Karmayogi Bharat, was published on the iGOT platform. The program is designed to equip officials with critical administrative, and technical skills, and help in seamless transition into their new roles within the government.
- iii. The LTC feature along with Dynamic Sanction Order has gone Live, that has enabled the nodal officer to edit / change the sanction order of his / her respective department / office.
- iv. The Google Analytics Dashboard integration has completed which allows the Super admin to view the total number of active users on the eHRMS 2.0 Portal.
- v. Sector Mapping of the iGOT courses have been completed and provisioned in Database to reflect on Dashboards. All 1000+ courses offered on the iGOT Karmayogi platform have been mapped to related sectors (e.g. Infrastructure, General Administration, Law and Order, Budgeting, Commerce, Education, Personnel Management, etc) and implemented on the eHRMS database.
- vi. iGOT Karmayogi platform crossed **1.18 crore plus course enrolments** and 83.7 lakhs plus course completions in May 2024.
- vii. iGOT Karmayogi platform hosts **34,91,838 on-boarded learners** as of May 2024. A total of 2,14,249 new users joined the Platform in May 2024.
- viii. The number of course completions in May 2024 was 9,76,775 and the total number of cumulative course completions till 31 May 2024 was **83,76,478**.
- ix. The number of active users (logged in once) on iGOT platform grew from **12.89 lakhs in April 2024 to 15.27 lakhs in May 2024**.
- x. iGOT Karmayogi portal recorded a cumulative **72.05 crore minutes of learning** as of 31 May 2024.
- xi. A total of sixty (60) content/courses were added to the platform. These are thirty seven (37) new courses, 3 curated programs, 6 Karmayogi

talks, and 14 resources in Gyan Karmayogi including Best Practices, Policies & Acts and Standalone Resources.

V. Welfare Measures

A summer coaching camp is being organized by CCSCSB for children aged 8 to 16 years from May 20th to June 19th, 2024 at Vinay Marg sports ground, New Delhi. The camp is to provide coaching in 7 different sports, including cricket, basketball, football, lawn tennis, Volleyball, self-defence and yoga.
