

IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL & TRAINING FOR THE MONTH OF APRIL, 2018

- (i) Smt. M. Sathiyavathy has been appointed as Member, Union Public Service Commission (UPSC) vide this Department's Order No.39019/12/2017-Estt(B) dated 04.04.2018.
- (ii) This Department has issued offer of provisional appointment to the 79 newly recruited Steno-D (2016) through SSC, who have been nominated for (SDR) foundation Training Programme at ISTM w.e.f. 23rd April, 2018 to 15th June, 2018.
- (iii) 397 candidates recommended for appointment as Assistant Section Officer by SSC were nominated for foundational training at ISTM and various State ATIs during this month.
- (iv) PESB, DoPT has advertised 01(One) post for CMD/MD and 08(Eight) posts for Director.
- (v) 30 training programmes were conducted in ISTM during the month of April. This includes 07 CSS-CTP (Level-E, Level-D, Level-B and Level-A) and 03 CSSS-CTP (Level-II and SDR) programmes. The number of participants in these programmes was 810.

No. 31011/12/2015-Estt.A-IV dated 24.04.2018.
- (ii) Declaration of Holiday on account of the birthday of Dr. B.R. Ambedkar, for all Central Government Offices including Industrial Establishments throughout India vide F.No. 12/6/2016-JCA-2 dated 02.04.2018.
- (iii) For gathering information regarding the functioning of Departmental Council in the Ministry/ Department during the last five years vide O.M. No.4/3/2009-JCA dated 24.04.2018.

- (iv) The rates of Central Secretariat (Deputation on Tenure) Allowance applicable to officers of All India Services and Organized Group 'A' Central Services on their appointment as Under Secretary, Deputy Secretary and Director in the Central Secretariat under the Central Staffing Scheme were revised vide O.M. No. 2/10/2017-Estt.Pay II dated 24.04.2018.
- (v) An employee on CCL may be permitted to leave headquarters with the prior approval of appropriate competent authority; LTC may be availed while an employee is on CCL; An employee on CCL may proceed on foreign travel provided clearances from appropriate competent authorities are taken in advance vide O.M. No. 13018/6/2013-Estt.(L) dated 03.04.2018.
