

## **IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL & TRAINING FOR THE MONTH OF DECEMBER, 2019**

- (i) Staff Selection Commission (SSC) has issued Notice of Combined Higher Secondary (10+2) Level Exam, 2019 on 03.12.2019 for filling up various Group 'C' posts in different Ministries/ Departments/ Offices of the Government of India.
- (ii) Staff Selection Commission (SSC) conducted following examinations:
  - Sub-Inspector in CAPFs, Astd. Sub-Inspector in CISF and Sub-Inspector in Delhi Police – 09.12.2019 to 13.12.2019 and on 31.12.2019
  - Combined Graduate Level-2018 (Tier-III) – 29.12.2019
  - Junior Engineers (Civil, Mechanical, Electrical and Quantity Surveying & Contract) Exam-2018 (Paper-II) – 29.12.2019

Also, the Commission has declared result of following examinations:

- Junior Engineers (Civil, Mechanical, Electrical and Quantity Surveying & Contract) Exam-2018 (Paper-I) – 12.12.2019
  - Assam Rifles Examination – 2018 on 17.12.2019
  - Combined Higher Secondary (10+2) Level Examination, 2017 (Final Result) – on 20.12.2019
- (iii) Appointments Committee of the Cabinet (ACC) approved appointments in 16 cases (03 CMD/MD and 13 Functional Directors) in various Schedule A & B Central Public Sector Enterprises (CPSEs). Further, seven (07) appointments of Chairpersons/Members in various Tribunals/ Statutory Bodies/ Authorities/ Commissions, three (03) appointments of Chief Executive in Autonomous Bodies/ Institutes, one (01) proposals of Appointment of PS, two (02) proposals of appointment of OSD, one (01) proposal of appointment to non-CSS post, five (05) proposals of extensions and two (02) proposals of Premature Repatriation were approved by the Cabinet Secretary/ACC.
  - (iv) 16 training programmes were conducted in Institute of Secretariat Training & Management (ISTM) during the month of December, 2019. This includes 03 CSS-CTP (Level-D-91, Level-D-92 and Level-A-90) and 01 CSSS-CTP (Level-I-14) programmes. The number of participants in these programmes was 483.
  - (v) Guidelines regarding revision of Scholarship Scheme for the children of Non-Statutory Departmental Canteen employees out of Discretionary Fund of Director of Canteens were issued vide O.M. No. 20/01/2011-Dir. (C) dated 24.12.2019.
