

## **IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL & TRAINING FOR THE MONTH OF FEBRUARY, 2018**

- i. Appointment's Committee of the Cabinet (ACC) has approved appointments in 02 cases (02 Functional Directors) in various Schedule A & B Central Public Sector Enterprises (CPSEs). Further, Eighteen (18) appointments of Chairpersons/Members in various Tribunals/ Statutory Bodies/ Authorities/ Commissions, Two (02) appointments of Chief Executives in Autonomous Bodies/ Institutes. Three (03) proposals of Premature repatriations, Two (02) proposals of Appointment of PS to Ministers, One (01) proposals of Appointment of OSD to Minister. Further, 04 officers have been retained on offer under the Central Staffing Scheme.
- ii. Pre-appointment formalities were initiated for 407 candidates, recommended by SSC on the basis of Combined Graduate Level Examination, 2016 for the post of Assistant Section Officer (ASO).
- iii. 29 training programmes were conducted in ISTM during the month of February. This includes 08 CSS-CTP (Level-E, Level-D, Level-B, Level-A and ASODR) programmes. The number of participants in these programmes was 725.
- iv. Orders regarding rotational transfer in the grade of Principal Private Secretary were issued vide Office Order No. 3/1/2017-CS.II(A) dated 20.02.2018.
- v. A Blood Donation Camp was organised in association with the Indian Red Cross Society, New Delhi at Ministry of Defence, South Block, New Delhi on 21.02.2018 and 78 employees donated blood in this camp.

2. In addition to the above, the following instructions / guidelines on different subjects have been issued by this Department.

- a) For grant of Paid Holiday to State Government Employees during General Elections to the Legislative Assembly of Tripura held on 18.02.2018 and to the Legislative Assemblies of Meghalaya and Nagaland held on 27.02.2018 vide O.M. No. 12/3/2016-JCA-2 dated 19.02.2018.
- b) "The Residents of the State of Jammu and Kashmir (Relaxation of Upper Age Limit for Recruitment to Central Civil Services and Posts) Rules, 2018", were issued vide notification No. 15012/1/2014-Estt.(D) dated 09.02.2018.
- c) For prescribing of maximum age limit in case of appointment on deputation/ deputation (including short term contract), instructions were issued vide O.M. No. AB-14017/7/2017-Estt.(RR) dated 05.02.2018.

- d) Guidelines on official dealings between Administration and Members of Parliament and State Legislatures were issued vide O.M. No. 11013/4/2018-Estt.A-III dated 07.02.2018.
- e) Instructions on applicability of Recommendations of 7<sup>th</sup> Central Pay Commission to Casual Labourers with Temporary status were issued vide O.M. No. 49011/2/2017-Estt.(C) dated 19.02.2018.
