

## **IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL & TRAINING FOR THE MONTH OF FEBRUARY, 2020**

- (i) In terms of Section 4(I) of the Central Vigilance Commission Act, 2003, the names of Shri Sanjay Kothari, IAS (Retd.) and Shri Suresh N. Patel, former MD & CEO, Andhra Bank have been recommended by the Committee under the Chairmanship of Hon'ble Prime Minister, for appointment as Central Vigilance Commissioner and Vigilance Commissioner respectively in the Central Vigilance Commission by the Hon'ble President of India.
- (ii) Offer of appointment issued to 371 ASOs of CGLE-2017 on 11.02.2020.
- (iii) Staff Selection Commission has declared result of following examinations:
  - Inspector in Delhi Police, CAPFs and Assistant Sub-Inspector in CISF Examination, 2018 (Paper-II).
  - Inspector in Delhi Police, CAPFs and Assistant Sub-Inspector in CISF Examination, 2019 (Paper-I).
  - Phase-VII/2019 Selection Post Examination (Matriculation, Higher Secondary (10+2) and Graduation & above level posts).
  - Annual Departmental Typewriting Skill Test and Annual Departmental Stenography Skill Test-2019.
  - Junior Hindi Translator, Junior Translator, Senior Hindi Translator and Hindi Pradhyapak Examination, 2018 (Final).
  - Combined Higher Secondary (10+2) Level Examination (CHSLE), 2018 to call candidates for Typing Test/ Data Entry Speed Test (DEST) for the posts of Postal Assistant, Sorting Assistant, Junior Secretariat Assistant, DEO, LDC etc.
- (iv) PESB, DoPT issued advertisements for 12 (twelve) posts [05 (five) posts of CMD/MD and 07 (seven) posts of Director].
- (v) Appointments Committee of the Cabinet (ACC) approved appointments in 09 cases (05 CMD/MD and 04 Functional Directors) in various Schedule A & B Central Public Sector Enterprises (CPSEs). Further, nineteen (19) appointments of Chairpersons/Members in various Tribunals/ Statutory Bodies/ Authorities/ Commissions, one (01) appointments of Chief Executive in Autonomous Bodies/ Institutes, one (01) proposal of appointment to non-CSS post, four (04) proposals of extensions and three (03) proposals of Premature repatriations were approved by the Cabinet Secretary/ACC.
- (vi) A conference on Integrated Government Online Training Programme (iGOT) with Cadre Controlling Authorities (CCAs) and Central Training Institutes (CTIs) was held on 04.02.2020 at Vigyan Bhavan under the Chairmanship of Principal Secretary to the Hon'ble Prime Minister for familiarizing them with a new digital capacity building framework to deliver online content and to examine the training requirements of Government officials at various levels of hierarchy.

(vii) 18 training programmes were conducted in Institute of Secretariat Training & Management (ISTM) during the month of February, 2020. This includes 01 CSS-CTP (Level-B-90) and 01 CSSS-CTP (L-V-01) programmes. The number of participants in these programmes was 487.
