

**IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL  
& TRAINING FOR THE MONTH OF JANUARY, 2020**

- (i) UPSC-33 proforma along with Checklist for receiving requisitions in Union Public Service Commission (UPSC) from Ministries/ Departments for post(s) by direct recruitment through selection, has been revised and circulated to all the Ministries/ Departments vide O.M. No. 39011/02/2019-Estt.(B) dated 16.01.2020.
- (ii) All the Ministries/ Departments in the Government of India have been advised to take time bound action to fill all the existing vacancies in their Ministries/ Departments vide O.M. No. 43014/03/2019-Estt.(B) dated 21.01.2020.
- (iii) Rear Admiral Shekhar Mital (Retd.) has been appointed as Member, PESB w.e.f. 15.01.2020 vide Notification No. 44011/7(s)/2019-Estt.(B-II) dated 30.01.2020.
- (iv) Pre-appointment formalities of 371 ASOs of CGLE-2017 were communicated vide letter dated 29.01.2020.
- (v) Staff Selection Commission has declared result of Paper-I of Junior Hindi Translator, Junior Translator, Senior Hindi Translator and Hindi Pradhypak Examination, 2019 on 29.01.2020.
- (vi) First Sports Day event of the Department organised at Vinay Marg Sports Complex on 25.01.2020.
- (vii) PESB, DoPT issued advertisements for 19 (nineteen) posts [06 (six) posts of CMD/MD and 13 (thirteen) posts of Director].
- (viii) Appointments Committee of the Cabinet (ACC) approved appointments in 03 cases (03 Functional Directors) in various Schedule A & B Central Public Sector Enterprises (CPSEs). Further, five (05) appointments of Chairpersons/Members in various Tribunals/ Statutory Bodies/ Authorities/ Commissions, three (03) appointments of Chief Executive in Autonomous Bodies/ Institutes, three (03) proposals of Appointment of PS, two (02) proposals of appointment of OSD, one (01) proposal of appointment to non-CSS post and five (05) proposals of extensions were approved by the Cabinet Secretary/ACC. Further, five (05) officers have been appointed as DCO and ACC has approved three (03) appointments of Joint Secretary (CVO).
- (ix) 20 training programmes were conducted in Institute of Secretariat Training & Management (ISTM) during the month of January, 2020. This includes 02 CSS-CTP (Level-E-61 and Level-B-89) and 03 CSSS-CTP (Level-III-42, L-III-43 and L-II-49) programmes. The number of participants in these programmes was 487.
