

IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL & TRAINING FOR THE MONTH OF JANUARY, 2021

(i) Staff Selection Commission has declared result of the following examinations:

- a) Constable (GD) in Central Armed Police Forces (CAPFs), NIA, SSF and Rifleman (GD) in Assam Rifles Examination - 2018.
- b) Junior Engineer (Civil, Electrical, Mechanical and Quantity Surveying & Contracts) Examination, 2018.
- c) Combined Higher Secondary (10+2) Level Examination (Tier-I), 2019.
- d) Junior Hindi Translator, Junior Translator and Senior Hindi Translator Examination (Paper-I), 2020.

(ii) Lokpal (Multi Tasking Staff, Group C posts) Recruitment Rules, 2021 published in the Gazette notification on 05.01.2021.

(iii) PESB, DoPT issued advertisements for 12 (twelve) posts [03 (three) for CMD/MD and 09 (nine) Directors].

(iv) Appointments Committee of the Cabinet (ACC) approved appointments in 05 cases (03 CMD and 02 Functional Directors) in various Schedule A & B Central Public Sector Enterprises (CPSEs). Further, one (01) appointment of Chairperson/Member in various Tribunals/ Statutory Bodies/ Authorities/ Commissions, four (04) appointments of Chief Executive in Autonomous Bodies/ Institutes, four (04) proposal of appointment to non-CSS posts, four (04) proposals of extensions and three (03) proposals of Premature repatriations were approved by the Cabinet Secretary/ACC.

(v) Union Public Service Commission (Exemption from Consultation) Amendment Regulations, 2021 were notified vide Gazette Notification No. 39018/03/2018-Estt.(B) dated 06.01.2021.

(vi) 17 (seventeen) training programmes including 04 (four) Organisation Specific Programme were conducted in Institute of Secretariat Training & Management (ISTM) during the month. The number of participants in these programmes was 560.

(vii) Creation of posts for National Recruitment Agency (NRA) was notified vide Notification No. 39020/08/2020-Estt. (B) dated 11.01.2021.

(viii) During the month promotions were done for the following:

- 231 PS were promoted as PPS on Ad-hoc basis.
- 48 PPS were promoted to Sr. PPS on Ad-hoc basis.

- (iii) Inclusion of sports discipline in the list of games for recruitment of meritorious sports persons to any post in Group 'C' in Ministries/ Department of Government of India, has been issued vide O.M. No. 14034/1/2013-Estt.(D) dated 29.01.2021.
