

IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL & TRAINING FOR THE MONTH OF JULY, 2019

- (i) Notification regarding Union Public Service Commission (Exemption from Consultation), Second Amendment, Regulations, 2019 was issued vide Gazette Notification No. 39018/01/2019-Estt. (B) [G.S.R. No. 472(E)] dated 04.07.2019.
- (ii) Notification regarding Central Civil Services (Conduct) Amendment Rules, 2019 was issued vide Gazette Notification No. 11013/02/2019-Estt. A-III [G.S.R. No. 531(E)] dated 29.07.2019.
- (iii) RTI Amendment Bill, 2019 was passed by the Lok Sabha on 22.07.2019 and by Rajya Sabha on 25.07.2019.
- (iv) Staff Selection Commission (SSC) conducted Combined Higher Secondary (10+2) Level Examination (Tier-I) 2018 from 01.07.2019 to 11.07.2019. Also, the Commission has uploaded the following information on its website:
 - i. The marks of Computer Based Examination of Constable (GD) in CAPFs, NIA, SSF & Rifleman (GD) in Assam Rifles Examination, 2018; and
 - ii. The final answer keys along with question papers of Sub Inspector in Delhi Police, CAPFs and ASI in CISF Examination (Paper-I), 2018.
- (v) Appointments Committee of the Cabinet (ACC) approved appointments in 14 cases (01 CMD/MD and 13 Functional Directors) in various Schedule A & B Central Public Sector Enterprises (CPSEs). Further, thirteen (13) appointments of Chairpersons/Members in various Tribunals/ Statutory Bodies/ Authorities/ Commissions, two (02) appointments of Chief Executives in Autonomous Bodies/ Institutes, four (04) proposals of premature repatriations, seventeen (17) proposals of appointment of PS, eleven (11) proposals of extensions, five (05) proposals of Appointment to OSD and one (01) proposal of curtailment of tenure were approved by the Cabinet Secretary/ACC. Further, eleven (11) officers were appointed as CVO.
- (vi) PESB, DoPT issued advertisements for 26(Twenty Six) posts [04(Four) posts for CMD/MD and 22(Twenty Two) posts for Director].
