

IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL & TRAINING FOR THE MONTH OF JUNE, 2017

1. The Online System for Monitoring of Disciplinary Proceedings was launched by Hon'ble MoS (PP) on 22/06/2017. The new system will expedite the proceedings against government employees involved in corruption cases.
2. Interaction and felicitation of Civil Services Examination, 2016 achievers by Hon'ble MoS (PP) was held on 02.06.2017 at North Block, New Delhi.
3. A new blended training programme called Comprehensive Online /Modified Modules on Induction Training (COMMIT) was digitally launched by Hon'ble MoS (PP) on June 29, 2017 at North Block. This programme will supplement the existing 12-Day Induction Training Programme (ITP) launched in 2014-15 for newly recruited frontline state government functionaries to develop in them Generic & Domain specific competencies.
4. On the occasion of 3rd International Day of Yoga on 21.06.2017, 250 Yoga Sadhaks from Grih Kalyan Kendra participated in the Yoga Session at Connaught Place, Lodhi Garden and Talkatora Stadium organized by Ministry of AYUSH. Besides, about 750 Yoga Sadhaks performed Yoga Sessions at their respective Samaj Sadans of Grih Kalyan Kendra in Delhi, Dehradun, Nagpur, Mumbai, Bangalore, Kolkata and Chennai on this occasion. The officials from DoPT performed Yoga in front of North Block on that day.

A copy of signed MoU was furnished to Cabinet Secretariat, which was executed between the Royal Civil Service Commission, Bhutan (RCSC) and Union Public Service Commission (UPSC) on 29.05.2017 for strengthening existing relationship between RCSC and UPSC, vide letter No. 39011/11/2015-Estt(B) dated 28.06.2017.
6. Appointment's Committee of the Cabinet (ACC) has approved appointments in 07 cases in various Schedule A & B Central Public Sector Enterprises (CPSEs). Further, Seventeen (17) appointments of Chairpersons/Members in various Tribunals/ Statutory Bodies/ Authorities/ commissions, Six (06) appointments of Chief Executives in Autonomous Bodies, Four (04) proposals of Premature repatriations, One (01) proposal of Appointment of OSD to Ministers, Three (03) proposals of Extensions, One (01) proposal of Curtailment of tenure and One (01) proposal of Lateral Shift has been approved by the Cabinet Secretary ACC. One (01) officer has been appointed as CVO and Nine (09) officers have been retained on offer under the Central Staffing Scheme.

7. Process of making manure by utilization of vegetable waste of DoPT canteen and utilization of Green and Blue containers for proper segregation of garbage was inaugurated by Secretary (P) on 30/06/2017.
8. Order issued {vide O.M. No. 31/26/2017-EO (MM-I) dated 27th June, 2017} for posting of the IAS officers of 2015 Batch as Assistant Secretary on central deputation in the different Ministries/Departments of Government of India for a period of 3 months from 03.07.2017 to 29.09.2017.
9. All India Services (Performance Appraisal Report) Amendment Rules, 2017 was notified on 15th June, 2017.
10. Central Civil Services (Classification, Control and Appeal) Amendment Rules, 2017 was notified on 02/06/2017.
11. Free Cancer Screening and Awareness camp was organized for employees of this Department on 14th June, 2017.
12. Blood Donation Camp was organised by DOP&T in association with the Indian Red Cross Society, New Delhi at North Block, New Delhi on 21.06.2017 and 43 employees donated blood in this camp.
