

IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL & TRAINING FOR THE MONTH OF JUNE, 2018

- (i) 4th International Day of Yoga was observed in DoPT, North Block on 21.06.2018 and a large number of officers and employees of this Department participated in the event.
- (ii) Summer Coaching Camp for wards of Central Government Employees was organised from 15.05.2018 to 15.06.2018.
- (iii) Office of Director (Canteens) facilitated FSSAI in organising training program of canteen employees on norms of Food Safety & Standards Act, 2006 to improve compliance of the law and general hygiene.
- (iv) 32 training programmes were conducted in ISTM during the month of June. This includes 14 CSS-CTP (03 Level-D, 06 ASODR, 02 Level-A, Level-E, 02 Level-B and 01 Level-A) and 06 CSSS-CTP (02 SDR-29 & 30, Level-III-28, 02 Level-II-33 & 34 and Level-IV-11) programmes. The numbers of participants in these programmes were 1240.
- (v) Notification pertaining to promotion of IAS cadre of Maharashtra was issued on 15.06.2018.
- (vi) Shri Sharad Kumar, IPS (HY: 1979) (Retired) was appointed, by the President, as the Vigilance Commissioner in the Central Vigilance Commission vide Warrant of Appointment dated 08.06.2018, for a term of four years from the date on which he entered upon his office or till he attains the age of sixty five years, whichever is earlier.
- (vii) Two (02) (SSA) candidates who qualified UD Grade LDCE-2015 & Ninety three (93) candidates who qualified LD Grade LDCE-2016 were nominated vide O.M. dated 19.06.2018.
- (viii) Approval of the Hon'ble President regarding appointment of Shri Sanjay Varma, IDAS (1998) as Member, Staff Selection Commission (SSC) with effect from June 21, 2018 till June 30, 2020, or until further orders, was conveyed vide Notification No. 24011/01/2016-Estt.(B) dated 29.06.2018.
- (ix) Approval of the Hon'ble President regarding appointment of Shri Arvind Saxena, Member, UPSC to perform the duties of the post of Chairman, Union Public Service Commission with effect from June 20, 2018 till further orders or till completion of his term as Member on August 07, 2020, whichever is earlier, was conveyed vide Notification No. 39019/05/2018-Estt.(B) dated 07.06.2018.

- (x) An amendment was made in Rule 43-C in order to remove the age limit of 22 years for availing Child Care Leave in respect of a disabled child. It was also decided that Child Care Leave may not be granted for a period of less than five days at a time vide Gazette Notification No. GSR 554 dated 06.06.2018.
- (xi) Appointment's Committee of the Cabinet (ACC) has approved appointments in 14 cases (3 CMD/MD and 11 Functional Directors) in various Schedule A & B Central Public Sector Enterprises (CPSEs). Further, Fourteen (14) appointments of Chairpersons/Members in various Tribunals/ Statutory Bodies/ Authorities/ Commissions, Four (04) appointments of Chief Executives in Autonomous Bodies/ Institutes. Seven (07) proposals of Premature repatriations, Two (02) proposals of Appointment of PS to Ministers, Four (04) proposals of Appointment of OSD to Ministers, Six (06) proposals of Extensions, Three (03) proposals of Curtailment of tenure have been approved by the Cabinet Secretary/ACC. Further, 16 officers have been retained on offer under the Central Staffing Scheme.
- (xii) Blood Donation Camp was organised by DOP&T in association with the Indian Red Cross Society, New Delhi at North Block, New Delhi on 20.06.2018 and 60 employees donated blood in this camp.
- (xiii) Order issued {vide O.M. No. 31/19/2018-EO (MM-I) dated 21st June, 2018} for posting of the IAS officers of 2016 Batch as Assistant Secretary on central deputation in the different Ministries/Departments of Government of India for a period of 13 weeks from 02.07.2018 to 28.09.2018. Also, order for allotment of accommodation to them was issued on 22.06.2018. In addition, other preparatory work with regard to their training and accommodation was also undertaken in right earnest.

- (i) Grant of special increment in the form of personal pay to Central Government Servants for participation in sporting events and tournaments of National or International importance, was issued vide O.M. No. 6/1/2017-Estt.(Pay-I) dated 11.06.2018.
- (ii) Instructions for implementation of the recommendation of 7th CPC on Overtime Allowance issued vide O.M. No. A-27016/03/2017-Estt.(L) dated 19.06.2018 .

- (iii) Instructions regarding Implementation of interim Orders/ directions in Special Leave to Appeal (C) No. 30621/2011 arising out of final judgement and order dated 15.07.2011 in CWP No. 13218/2009 passed by the Hon'ble High Court of Punjab & Haryana and Special Leave to Appeal (C) No. 31288/2017 arising out of Hon'ble Delhi High Court judgement dated 23.08.2017 and other related cases issued vide O.M. No. 36012/11/2016-Estt.(Res-I) {Pt-II} dated 15.06.2018.
- (iv) Posting of sixty nine (69) newly recruited Stenographers after completion of SDR training on 15.06.2018, in the Ministries/ Departments with effect from 18.06.2018.
- (v) Appointment of Chairman (CAT, PB), Chairman, West Bengal Administrative Tribunal (WBAT) and one Administrative Member in WBAT.
