

**IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL  
& TRAINING FOR THE MONTH OF JUNE, 2019**

- (i) Staff Selection Commission (SSC) declared the result of Written Examination of Constables (GD) in CAPFs, NIA, SSF and Riflemen (GD) in Assam Rifles Examination, 2018 on 20.06.2019. Also the Commission has conducted Combined Graduate Level Examination (Tier-I) 2018 from 04.06.2019 to 13.06.2019.
- (ii) Appointments Committee of the Cabinet (ACC) approved appointments in 08 cases (03 CMD/MD and 05 Functional Directors) in various Schedule A & B Central Public Sector Enterprises (CPSEs). Further, thirteen (13) appointments of Chairpersons/Members in various Tribunals/ Statutory Bodies/ Authorities/ Commissions, three (03) appointments of Chief Executives in Autonomous Bodies/ Institutes, one (01) proposals of premature repatriations, fourteen (14) proposals of appointment of PS, six (06) proposals of extensions and one (01) proposal of curtailment of tenure were approved by the Cabinet Secretary/ACC. Further, orders issued for appointment of 169 IAS officers of 2017 Batch as Assistant Secretaries on Central deputation in various Ministries/ Departments.
- (iii) PESB, DoPT issued advertisements for 18(Eighteen) posts [07(Seven) posts for CMD/MD and 11(Eleven) posts for Director].
- (iv) Performance of 71 PPSs of CSSS were reviewed under FR 56 (j).
- (v) 16 training programmes were conducted in ISTM during the month of June. This included 05 CSS-CTP and 01 CSSS-CTP programmes. The number of participants in these programmes was 460.
- (vi) Orders regarding Holidays to be observed in Central Government Offices during the year 2020 were issued vide O.M. No. 12/1/2019-JCA-2 dated 18.06.2019.
- (vii) Shri Rajiv Srivastava, IOFS (1991) was appointed as Member, Staff Selection Commission vide O.M. No. 24011/01/2016-Estt.(B) dated 11.06.2019.
- (viii) Zone of consideration for adhoc promotions of 1135 ASOs to SOs was issued on 14<sup>th</sup> June, 2019.
- (ix) Terms & Conditions of deputation of Assistant Secretaries to the Central Government were finalized on 19<sup>th</sup> June, 2019.
