

## **IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL & TRAINING FOR THE MONTH OF JUNE, 2021**

(i) Staff Selection Commission has reviewed the situation arising out of the Corona Virus pandemic from time to time and issued Notices dated 02.06.2021 and 25.06.2021 postponing the Exam related activities in the interest of the Candidates.

Also, the Commission declared result of the following examinations:

- a) Junior Engineer (Civil, Mechanical, Electrical and Quantity Surveying & Contract) Examination (Paper-I), 2020.
- b) Combined Graduate Level Examination (Tier-III), 2019.
- c) Combined Higher Secondary (10+2) Level Examination (CHSLE-Typing Test/DEST), 2018.
- d) Sub-Inspector in Delhi Police, CAPFs and Assistant Sub-Inspector in CISF Examination [Physical Endurance Test (PET)/ Physical Standard Test (PST)], 2019.

(ii) Acceptance of nomination of 954 candidates selected as DR ASOs through CGLE 2018. Initiation of activities related to completion of pre-appointment formalities by these 954 ASOs through ONLINE PORTAL for the first time.

(iii) Two increments were granted to DS/Sr. PPS on promotion from US/PPS in CSS/CSSS vide O.M. No. 18/03/2018-CS.I (P) dated 22.06.2021.

(iv) PESB, DoPT issued advertisements for 04 (four) posts [03 (three) posts of Director and 01 (one) post of Managing Director].

(v) A list of holidays to be observed in the Central Government Offices during the year 2022 was issued vide O.M. No. 12/5/2021-JCA dated 08.06.2021.

(vi) All the Ministries/ Departments were requested for filling up of vacant posts in Central Government Ministries/ Departments vide O.M. No. 43014/03/2019-Estt.(B) dated 03.06.2021.

(vii) Union Public Service Commission (Exemption from Consultation), Second Amendment, Regulations, 2021 were notified vide Gazette Notification dated 11.06.2021.

(viii) Shri Sanjeeb Kumar Mishra, IAS (OD:1997) is appointed as Secretary-cum-Controller of Examination, National Recruitment Agency (NRA), New Delhi, for a tenure of five years w.e.f. 03.06.2021 (FN) i.e. 02.06.2026 or until further orders, whichever is earlier.

(ix) Additional charge of the post of Chairman, Staff Selection Commission assigned to Ms. Deepti Umashankar, IAS (HY:1993), Additional Secretary, DOPT for a period of 06 months w.e.f. the date of her assumption of charge of

the post, or till the appointment of a regular incumbent to the post, or until further orders, whichever is the earliest.

(x) SSAs belonging to SL-2009 and the debarred SSAs belonging to SL-2004 to 2008 of Central Secretariat Clerical Service (CSCS) were promoted to the grade of ASO of Central Secretariat Service (CSS) on ad-hoc basis vide O.M. No. 11/1/2020-CS.II(B) dated 15.06.2021.

(xi) Task Force on Special Purpose Vehicle (SPV) was formed as per Order No. T-16017/08/2021-iGOT Karmayogi dated **23<sup>rd</sup> June, 2021**. It has been formed in order to facilitate a road map for SPV formation. It is chaired by Sh. SD Shibu Lal with Sh. Govind Iyer and Sh. Pankaj Bansal as Members.

(xii) Shri Adil Zainul Abidin Bhai, has joined as part time Chairperson of the Capacity Building Commission on 28<sup>th</sup> June, 2021 along with Shri Ramaswami Balasubramaniam who joined as whole time Member HR. Shri Praveen Pardesi, IAS (MH:85) joined as Member Administration on 1<sup>st</sup> July, 2021. With the posting of secretariat staff in the Commission it has become operational from their temporary administrative office location at NDCC Building 2<sup>nd</sup> Floor.
