

**IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL
& TRAINING FOR THE MONTH OF MARCH, 2019**

- (i) Hon'ble President appointed Mr. Justice Pinaki Chandra Ghose as the Chairperson, Lokpal with effect from 23.03.2019 (forenoon) vide Gazette Notification No.407/002/2019-AVD-IV(LP)(Part.II) dated 25.03.2019. Further, following eight (08) person were appointed as Members of Lokpal under the Lokpal and Lokayuktas Act, 2013, with effect from 27.03.2019 (forenoon) vide Gazette Notification No.407/002/2019-AVD-IV(LP)(Part.II) dated 27.03.2019:

- (ii) The Staff Selection Commission conducted following two Examinations in the month of March:-
- a) Examination for recruitment of Constables (GD) in CAPFs, NIA, SSF and Rifleman (GD) in Assam Rifles was conducted for 52.20 lakh candidates between 11.02.2019 to 11.03.2019.
 - b) Examination for SI in Delhi Police, CAPFs and ASI in CISF (Paper-I)-2018 between 12.03.2019 to 16.03.2019 for 8, 20,683 candidates.
- (iii) The Staff Selection Commission declared following two Results in the month of March:-
- a) Result of Paper-I of Junior Hindi Translator, Junior Translator, Senior Hindi Translator and Hindi Pradhyapak Examination 2018 on 22.03.2019.
 - b) Final result of Stenographer Grade 'C' & 'D' Examination 2017 on 29.03.2019.
- (iv) Appointments Committee of the Cabinet (ACC) approved appointments in 05 cases (05 Functional Directors) in various Schedule A & B Central Public Sector Enterprises (CPSEs). Further, fifteen (15) appointments of Chairpersons/Members in various Tribunals/ Statutory Bodies/ Authorities/ Commissions, nine (09) appointments of Chief Executives in Autonomous Bodies/ Institutes, four (04) proposals of Premature repatriations, two (02) proposals of Appointment of OSD to Ministers, ten (10) proposals of extensions and one (01) proposal of Re-designation were approved by the Cabinet Secretary/ACC. Further, four(04) officers have been appointed as CVO.
- (v) PESB, DoPT issued advertisements for 09(Nine) posts [04(Four) post for CMD and 05(Five) posts for Director].

- (vi) Central Civil Services Cultural and Sports Board (CCSCSB) organized half marathon for Central Government Employees and their family members on 03.03.2019 at Vinay Marg. Around 1000 persons participated in the event.
- (vii) Central Civil Services Cultural and Sports Board (CCSCSB) organized All India Civil Services Carrom tournament 2018-19 at New Delhi. A total of 31 teams participated in the tournament, consisting of 450 participants.
- (viii) 173 candidates were nominated under CSS-CTP for the level 'B' training program starting from 25.03.2019.
- (ix) A total of 463 officers (277 ASO and 186 SO) were reviewed under FR 56.
