

## **IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL & TRAINING FOR THE MONTH OF MARCH, 2021**

(i) Staff Selection Commission has declared the result of the following examinations:

- a) Multi-Tasking (Non-Technical) Staff Examination, 2019.
- b) Junior Engineer (Civil, Mechanical, Electrical and Quantity Surveying & Contracts) Examination (Paper-I), 2019.
- c) Constable (Executive) Male and Female in Delhi Police Examination, 2020.
- d) Stenograph Grade 'C' & 'D' Examination, 2019.
- e) Sub-Inspector in Delhi Police and CAPFs Examination (Paper-I), 2020.

Also, the Commission has conducted the following examination:

- a) Junior Engineer (Civil, Mechanical, Electrical and Quantity Surveying & Contracts) Examination (Paper-II), 2019 and Junior Engineer Examination (Paper-II), 2020.

(ii) CCSCSB successfully organized the All India Best Physique Championship on 24<sup>th</sup> March 2021 and the All India Wrestling Championship from 25<sup>th</sup> to 27<sup>th</sup> March 2021, in Delhi.
