

IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL & TRAINING FOR THE MONTH OF OCTOBER, 2018

- (i) Notification regarding the Staff Selection Commission (Chairman and Members) Recruitment Rules, 2018, issued vide Gazette notification No. 39021/03/2018-Estt.(B) Pt. dated 18.10.2018.
- (ii) Special Cleanliness Drive was undertaken by officers/ officials of this Department on 25th October, 2018 in Pijanji village, New Delhi.
- (iii) Indian Police Service (Fixation of Cadre Strength) Second Amendment Regulations, 2018 relating to posts of Indian police Service in respect of Maharashtra Cadre were notified vide Gazette notification No. 11052/04/2017-AIS-II (A) dated 16.10.2018.
- (iv) Indian Police Service (Pay) Second Amendment Rules, 2018 relating to posts of Indian police Service under the State Government of Maharashtra were notified vide Gazette notification No. 11052/04/2017-AIS-II (B) dated 16.10.2018
- (v) Indian Police Service (Pay) Third Amendment Rules, 2018 relating to posts of Indian police Service under the State Government of Odisha were notified vide Gazette notification No. 11052/10/2017-AIS-II (B) dated 18.10.2018.
- (vi) Appointment's Committee of the Cabinet (ACC) approved appointments in 16 cases (01 CMD/MD and 15 Functional Directors) in various Schedule A & B Central Public Sector Enterprises (CPSEs). Further, thirty (30) appointments of Chairpersons/Members in various Tribunals/ Statutory Bodies/ Authorities/ Commissions, eight (08) appointments of Chief Executives in Autonomous Bodies/ Institutes, two (02) proposal of Premature repatriation, one (01) proposals of Appointment of PS/OSD to Ministers, twelve (12) proposals of extensions, four (04) proposal of curtailment of tenure, four (04) proposal of Appointment (Non-CSS) and four (04) proposals of Re-designation were approved by the Cabinet Secretary/ACC. Further, 04 officers have been retained on offer under the Central Staffing Scheme.
- (vii) The Staff Selection Commission has declared the final result of the following two examinations:-
 - a) Junior Engineer (Civil, Mechanical, Electrical and Quantity Surveying & Contract) Examination, 2017, wherein a total of 341 candidates have been finally recommended for appointment in different Ministries/ Departments of the Government of India.

- b) Sub inspector in Delhi Police, CAPFs and ASI in CISF, Examination, 2017 wherein a total of 3353 candidates have been finally recommended by the Commission for appointment in the Delhi Police and various Central Armed Police Forces under the Ministry of Home Affairs.
- (viii) The Staff Selection Commission has published Examination Notices for 02 All India Open Competitive Examinations, namely:-
- a) Stenographer 'C' & 'D' Examination, 2018.
 - b) Junior Hindi Translator, Junior Translator and Senior Hindi Translator and Pradhyapak Examination, 2018.
- (ix) PESB, DoPT issued advertisement for 04(Four) posts [02(Two) post for CMD and 02(Two) posts for Director].
- (x) 19 ad-hoc Under Secretaries and 7 Section officers were promoted as regular Under Secretaries on 16.10.2018.
