

IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL & TRAINING FOR THE MONTH OF SEPTEMBER, 2019

- (i) The Annual Conference of Chief Secretaries of States/ UTs under the chairmanship of Hon'ble MoS (PP) was conducted on 18.09.2019 at Vigyan Bhawan, New Delhi to discuss the issues relating to Personnel Management of all three All India Services' officers.
- (ii) Staff Selection Commission (SSC) conducted following examinations:
 - Combined Graduate Level Exam (T-II) – 11.09.2019 to 14.09.2019
 - Junior Engineers Exam-2018 (Paper-I) – 23.09.2019 to 27.09.2019
 - Sub-Inspector in CPO Exam, 2018 (Paper-II, 27.09.2019
 - Combined Higher Secondary Level Exam (P-II) – 29.09.2019

Also, the Commission has declared result of following examinations:

- Combined Higher Secondary (10+2) Level Examination, 2018 (Paper-I) – on 12.09.2019
 - Sub-Inspector in Delhi Police, CAPFs and ASI in CISF Examination, 2018 (Result of PET/PST) – on 09.09.2019
 - Junior Hindi Translator, Junior Translator, Senior Hindi Translator and Hindi Pradhypak Examination, 2018 (Paper-II) – on 04.09.2019
- (iii) Appointments Committee of the Cabinet (ACC) approved appointments in 07 cases (02 CMD/MD and 05 Functional Directors) in various Schedule A & B Central Public Sector Enterprises (CPSEs). Further, three (03) appointments of Chairpersons/Members in various Tribunals/ Statutory Bodies/ Authorities/ Commissions, one (01) appointment of Chief Executive in Autonomous Bodies/ Institutes, six (06) proposals of Appointment of PS to Ministers, one (01) proposals of Appointment of OSD to Ministers, two (02) proposals of Premature repatriations and two (02) proposals of extensions were approved by the Cabinet Secretary/ACC.
 - (iv) PESB, DoPT issued advertisements for 02 (two) posts of Director and 14 (fourteen) selection meetings were held (02 for CMD/MD and 12 for Director).
 - (v) 08 (eight) Joint Secretaries have been appointed in different Ministries/ Departments in the Government of India under the Lateral Recruitment policy.
 - (vi) Third Amendment in Union Public Service Commission (Exemption from Consultation) Regulations, 1958 was notified vide Gazette Notification dated 19.09.2019.
 - (vii) Central Civil Services Cultural and Sports Board (CCSCSB) organized a Cricket match played between Assistant Secretaries XI and Cabinet Secretaries XI at Siri Fort Sportys Complex on 29.09.2019.
 - (viii) 23 training programmes were conducted in ISTM during the month of September. This included 03 CSS-CTP and 04 CSSS-CTP programmes. The number of participants in these programmes was 580.

No. 2/11/2019-Estt.(Pay-II), dated 17.09.2019.
- (iii) Grant of paid holiday to employees on the day of poll in Bye elections to State Legislative Assemblies for Chattisgarh, Kerala, Tripura and Uttar Pradesh on 23.09.2019 (Monday) vide O.M. No. 12/3/2016-JCA-2 dated 12.09.2019.
