

IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL & TRAINING FOR THE MONTH OF SEPTEMBER, 2021

- (i) All India Services (Conduct) Amendment, Rules, 2021 were notified vide Gazette Notification No. 11017/01/2019-AIS-III dated 15.09.2021.
- (ii) Encadrement of various posts in the National Medical Commission (NMC) was issued vide order dated 06.09.2021. Further, 44 CSS officers were posted to NMC vide Orders dated 15.09.2021 and 22.09.2021.
- (iii) Foundational Training Programme (FTP) of Combined Graduate Level Examination (CGLE) 2018 candidates (ASOs) (initiated on 20.09.2021) was inaugurated by Hon'ble MoS (PP).
- (iv) Rules of Section Officers/Stenographers (Grade B/Grade I) Limited Departmental Competitive Examination, 2016 & 2017 were notified on 15.09.2021.
- (v) Union Public Service Commission (Exemption from Consultation), Fourth Amendment, Regulations, 2021 were notified vide Gazette Notification No. 39018/01/2021-Estt. (B) dated 29.09.2021.
- (vi) An Orientation programme to orient and sensitize Minister's Team i.e. PS, OSD and other personal staff attached with Union Ministers regarding the expectations and understanding of the larger objectives of the Government and to help build capacity in specific functionalities, skills, processes and tools, was held on 26.09.2021 at Sushma Swaraj Bhawan, Chanakyapuri, New Delhi. 214 Officers attended the programme.
- (vii) PESB, DoPT issued advertisements for 07 (seven) posts of Chairman and Directors/Managing Director and 11 (eleven) posts of Directors. Also, 03 (three) Selection Meetings were held for Directors.
- (viii) A Committee has been constituted under the chairmanship of Dr. C Chandramouli IAS (Retd.) to determine the number of IAS officers to be recruited through Civil Services Examination for the year 2022-2030.
- (ix) Approval of MoS(PP) has been solicited for relaxation in approved service of Stenographers 'D' of 2010 batch in consultation with UPSC.
- (x) A High Level Steering Committee under the Chairmanship of Secretary(P) has been constituted to ensure coordination with CBC, SPV, ISTM and other agencies associated with National Program for Civil Services Capacity Building (NPCSCB), vide O.M. No. T-16017/20/2021-iGOT dated 06.09.2021.
