### Overview

Department of Personnel and Training (DoPT) has identified 51 role-specific online courses available on various EdTech platforms. These courses are self-paced, aligned with thematic domains relevant to the context of governance in India and mapped with corresponding domain, functional and behavioral competencies expected of civil servants working together in the pursuit of a Viksit Bharat. Along with the relevant thematic domain, each course is also mapped with specific public roles and will be useful in building next-level competencies relevant for the defined roles/domains.

The listed online courses can be consumed directly on the respective platforms (by logging into the platform and enrolling for a chosen course on certificate track). Upon completion of the course, the officer may apply online for reimbursement of the course fee from DoPT. Reimbursement will be made on the basis of the course completion certificate and the receipt of fee payment (generated on the EdTech platform) furnished by the officer. The modalities of reimbursement are being detailed out in a separate circular.

It is emphasized that each course has been mapped to one of the 27 thematic domains and categorically tagged to specific roles in terms of domain/functional competencies targeted. It is necessary that an officer selects courses that are relevant to the domain and/or the role that she/he is discharging currently or have discharged at some point of time. Officers may also pursue courses whose subject matter has been covered as part of their respective academic qualifications.



# **Eligibility**

Officer fulfilling any of the mentioned criteria are eligible for claiming reimbursement:

- Officers of All India Services (IAS/ IPS/ IFoS) with minimum 4 years of service (as on April
  01 of any given year),
- Officers working under Central Staffing Scheme,
- Officers of Central Secretariat Service and Central Secretariat Stenographers Service (at or above the rank of Deputy Secretary/Sr. Principal Private Secretary)

### Validation & Restriction on Ed-Tech Reimbursement claims

This reimbursement scheme shall be available only for officers of All India Services with minimum 4 years of service (as on April 01 of any given year), Officers working under Central Staffing Scheme, Officers of Central Secretariat Service and Central Secretariat Stenographers Service (at or above the rank of Deputy Secretary/Sr. Principal Private Secretary).

Eligible officers shall be reimbursed up to a maximum of five courses and subject to an overall ceiling of Rs. 27,000 per officer per financial year (April - March).

While eligible officers are encouraged to avail the facility with immediate effect (i.e. 1st Feb 2025), the reimbursement requests shall be entertained with effect from April 0 1, 2025. Courses, if any, consumed after the date of issue of this OM and up till March 31, 2026 shall be counted against the limit viz., number of courses, reimbursement amount for the financial year 2025-26.




# Application submission Process for Reimbursement fee for role specific online courses through Edtech platform on E-HRMS- (Non - Onboarded Officers)

Officers who are not yet onboarded on the e-HRMS portal must first complete a one-time registration process on e-HRMS before submitting their reimbursement claims for online role-specific courses undertaken on the EdTech platform

# **Step 1: Login and Accessing the Registration Form**

- 1. Officers must login to E-HRMS (https://e-hrms.gov.in/login) using their E-Parichay credentials.
- 2. Upon successful login, a hyperlink labeled "**Training Registration**" will be available on the pop -up message.
- 3. Clicking on this link will open the **Training Registration Form**.



**Training Registration form** is divided into two Sections - Personal Information and Organizational information


# **Personal Information Section**

In the **Personal Information section**, officers are requested to provide the following details:

- Name: This field will be auto-populated from the E-Parichay Database.
- **Service:** Select the service through which you are employed.
- **Batch:** Choose the batch year corresponding to your employment.
- Cadre: Specify the cadre in which you are serving.
- Present Designation: Enter your current designation.
- Date of Birth: Select your date of birth from the calendar option.



- Gender: Specify your gender.
- **Primary Email ID –** Auto-populated (E-parichay Database)
- Alternate Email ID Provide an alternative email
- Mobile Number Auto-populated (E-parichay Database)
- Office Landline Number Provide the official landline number, if applicable
- Pay Level Enter the pay level as per official records




# **Organization Information Section**

- Ministry/Department/State/UT Government: Select the relevant Ministry, Department, State, or Union Territory Government where you are currently posted.
  - If the associated ministry is not listed in the dropdown, select the "Other" option and manually enter the ministry details.
- Name of Controlling Authority: Enter the full name of the concerned officer in Controlling Authority in the present organisation.
- **Designation of Controlling Authority:** Specify the designation of the Controlling Authority.
- Email ID of Controlling Authority: Provide the official email address of the Controlling Authority.
- Upload Issued ID Card or CCA Certificate: Upload a clear and complete scanned copy of the issued ID card or the duly signed Controlling/Competent Authority (CCA) Certificate. Only pdf files can be uploaded.

**Note:** A template for the CCA Certificate can be downloaded from the portal. It must be signed by the appropriate authority before uploading.


# **Step 2: Accessing Edtech Training Reimbursement Form**

Once the registration process is successfully completed, the officer will be assigned the role of a **Guest User** on the **E-HRMS portal**.

To access the claims for reimbursement of fee for training courses completed, please follow these steps:

- 1. Navigate to the **left-hand side menu** on the portal.
- 2. Go to Employee Service > **Training Reimbursement**
- 3. On clicking the Training **Reimbursement form** will appear. Fill in the details (Process for filling the form is at Page no. 9)

(Officers are kindly advised to ensure that they meet the eligibility criteria before applying for any reimbursement claim.)






# Application submission Process for Reimbursement fee for role specific online courses through Edtech platform on E-HRMS (Onboarded Officer on E-HRMS)

Officers already onboarded on **E-HRMS** (<a href="https://e-hrms.gov.in/login">https://e-hrms.gov.in/login</a>) can submit their reimbursement claim for online role specific identified courses undertaken on Edtech platform, directly by filling the reimbursement claim form.

# Step 1: Accessing the Edtech Training Reimbursement Section on E-HRMS


- 1. Log in to **E-HRMS Portal** using your **Employee Role** credentials.
- 2. Navigate to **Employee Services>Reimbursement** in the left hand menu.
- 3. Click on Role specific online courses through EdTech platform Tile.






# Training Reimbursement form (Common for all officer - onboarded & non-boarded)

1. **Initiating Claim request:** Upon clicking the tile, EdTech Training Reimbursement form will be available, click on the **Add Reimbursement Request** button.




2. **Eligibility check:** The system will verify the eligibility of the officer. If the officer is found ineligible for EdTech Training Reimbursement, a pop-up message will be displayed notifying them of their ineligibility. To view the detailed eligibility criteria for EdTech Training Reimbursement, please click on the "Link" provided.






- **3. Verification of Officer and Banking Details:** If the officer is eligible to submit claims, the system will verify the availability of bank account details registered under the parichay account logged in on the PFMS portal..
  - a. If the officer is already registered with the PFMS portal, the banking details available in PFMS will be automatically displayed. Before submitting a reimbursement request, officers are advised to carefully review and verify the following banking details:
    - Bank Account Details
    - IFSC Code



b. If the officer is not found to be registered on the PFMS portal, the system will display a pop-up message prompting re-verification of PFMS registration using the PAN. Please enter the PAN and click the 'Check' button to proceed.





Case I- If banking details are available for your PAN on the PFMS portal, the system will display the registered bank account information in a pop-up window.




**Case II-** If no bank account is registered against your PAN on the PFMS portal, a pop-up message will be displayed indicating the same.




Thereafter, a pop-up page will appear asking the officer to fill: Name, City in which the account is held, Bank Account Number, and IFSC Code. This is required for registration of Bank details on PFMS. Please provide accurate details as available in your respective bank records.

Before submitting the request, please ensure that all details entered are accurate.






PFMS registration process takes 5 minutes. Therefore, claim for reimbursement can be initiated only after PFMS registration is completed.




- 4. Adding reimbursement Claims for EdTech Course: Once the PFMS registration is successfully completed, the registered details will be displayed at the top of the "Add Reimbursement" section. The officer can fill in the claim form providing following information related to the completed course for which the reimbursement request is being filed:
  - a. Year of completion of course.
  - b. **EdTech Platform** Select from the dop down list such as Coursera, edX, etc.
  - c. **Course completed** Select from the drop down list. (Based on the selected platform, available courses will be displayed for selection)
  - d. **Date of registration on portal-** Date of the registration on the edtech platform **for the selected** Course.



- e. Date of course completion- Date of completion of the selected course.
- f. **Amount Paid** The fee paid for the selected course. It should be same as is mentioned in the payment receipt.
- g. **Completion Certificate** Upload the completion certificate in PDF format (maximum file size: 5 MB).
- h. **Payment Receipt** Upload the invoice of the fee payment made for the course in PDF format (maximum file size: 5 MB).
- 5. Submission of Multiple Course Reimbursements: Claim can be submitted for more courses at a by clicking the "Add More Course" option and entering the respective details for each additional course. Once all claim details have been added, the officer must review the information and click on Submit for processing the reimbursement request.




Before submitting the edtech reimbursement request, the system displays an alert message prompting the user to verify the entered information.





6. Tracking reimbursement claim status: Once the claims are submitted, the details of the submitted claims can be viewed by clicking the View button located in the Action column on the list page. Additionally, the officer can monitor the status of the reimbursement request and view the amount reimbursed directly from the list page. This allows officers to easily track the progress and financial details associated with their reimbursement submissions.



7. Rejection/ resubmission of claims: If a claim is rejected by the competent authority, the reason for rejection will be mentioned in the remarks. In such cases, a revised claim may be submitted with the necessary supporting documents. Care should be taken to ensure that the issues raised in the earlier submission are appropriately addressed.

# Guidelines for Reimbursement of or role-specific, online courses through Edtech Platform sponsored by DoPT for Government Officers

# 1. Objective

- To facilitate the upskilling of government officers through **self-paced**, **role-specific** online courses.
- To address the **training gap** in In-Service Training (IST) Programs by enabling officers to access **high-quality courses** on **EdTech platforms**.
- **2. Eligibility Criteria:** Officers fulfilling any of the below mentioned conditions are eligible for claiming reimbursement of online courses fee
  - Officers of **All India Services (IAS, IPS, IFoS)** with a **minimum of 4 years of service** (as of April 1, 2025).
  - Officers working under the Central Staffing Scheme only.
  - Officers of Central Secretariat Service (CSS) and Central Secretariat Stenographers Service (CSSS) at or above the rank of Deputy Secretary/Sr. PPS.

# 3. Approved Course Platforms & Subjects

• The **Department of Personnel and Training (DoPT)** has identified **30 courses** from Coursera **platform and 21 courses** from **EdX** platform. These courses are mapped to **27 thematic domains** relevant to governance.

# 4. Financial Ceiling for Reimbursement

- The annual reimbursement ceiling for each officer is ₹27,000 (excluding taxes) or as indicated by DoPT through its OMs every year.
- The **bucket of courses** offered by DoPT will be available **every year**, allowing officers to enroll in new courses annually.
- Courses with fees exceeding ₹27,000 are not eligible for reimbursement.
- Reimbursement in a year can be claimed through multiple claims, ensuring the total amount does not exceed the prescribed limit by DoPT.
- The fee included in Annexure A of OM no. F.No. T-22012/8/2024-IST/IIPA dated 29<sup>th</sup> January 2025 is an indicative fee which may vary from the fee charged at the portal. The officer shall have to pay the fee as mentioned on the platform and claim the same to DOPT.

# 5. Course Availability & Reimbursement Criteria

- Certain courses may be **archived** for a variety of reasons including but not limited to course revision, low enrolment rate, completion of courses with live components etc., by the respective universities and shall be unavailable for earning certificates or badges until made available by the university.
- The reference point for reimbursement is the year in which the payment of fees was made.

- To avail **full reimbursement** in a given financial year, officers shall complete the course within March 31<sup>st</sup> of the subsequent year.
- Officers are requested to submit bills on either completion of 5 courses or having spent the maximum reimbursement ceiling whichever is earlier, for ease of processing.

## 6. Enrolment & Reimbursement Process

- Officers must register on the listed platform for any of the courses included in the DoPT's list.
- Officers need to **follow the platform's process** for course consumption, fee payment, and assessment.
- Only upon receiving the **completion certificate**, the officer can apply for reimbursement on the **e-HRMS portal**.
- Officers not registered on e-HRMS must first complete a one-time registration before submitting reimbursement claims.
- The claim submission will be done through the dedicated page on the e-HRMS portal, and funds will be transferred directly to the learner's/ officer's bank account.
- The link of the portal for submission of claims is <a href="https://e-hrms.gov.in/login">https://e-hrms.gov.in/login</a> . The step by step guide with visuals on submission of claims is included at Annexure I.

## 7. Restrictions & Conditions

- Claims for any course not included in the DoPT list will not be entertained.
- Mere submission of claims on e-HRMS portal does not entitle the officer for reimbursement. Based on the eligibility, DoPT shall scrutinize the claims and reserves the right to reject the claim.

# 8. Integration with iGOT-Karmayogi

- These **self-paced** online courses will complement existing **In-Service Training Programs** conducted by **ATIs/CTIs**.
- The long-term plan includes integrating high-quality courses from external EdTech platforms into iGOT-Karmayogi.
- Email id registered on iGOT shall be synchronous with the email id on e-HRMS which shall help in updating the competency pass book of the learner on iGOT. Officers are using different email IDs for e-HRMS and iGOT may provide their iGOT email ID while applying for reimbursements.

# 9. Publicity & Awareness

- All Ministries/Departments/State Governments/UT Administrations should ensure wide dissemination of this scheme.
- Eligible officers should be encouraged to **enroll and benefit** from these courses.

# 10. Implementation Timeline

- Effective from April 1, 2025.
- Courses completed between the issue date of this OM (29th January 2025) and March 31, 2026, will be counted towards the 2025-26 financial year quota.
