Please refer to the subject mentioned above and to say that the Commission has declared the result of Skill Test of the said examination on 03.12.2023 for evaluation of APARs. In the said result the total 31 candidates of CSSS Cadre have qualified and are eligible for evaluation of their APARs (List of 31 candidates is attached).

2. Part-C of the scheme of the examination provides for evaluation of record of service carrying a maximum of 100 marks of such candidates who may attain a qualifying standard, as may be fixed by the Commission in its discretion, in the written part of the examination. It is, therefore, requested that the certified copies of APARs of the above mentioned candidates for the years from 2011-12 to 2015-16 (05 Years) complete in all respects may be sent to the undersigned by name in double sealed covers as early as possible and in any case not later than 31.12.2023 (through Special Messenger). Kindly note that if the APARs are not received in the Commission by the stipulated date, the Commission shall not be responsible for any consequence that may flow from non-receipt of complete APARs. While sending the APARs of the candidate, you may kindly mention the Roll Numbers of the candidates against their respective names and also on the APAR dossiers.

3. In this connection, it is stated that for the purpose of the evaluation of service records of the candidates mentioned in para-1, it is very important that their APARs are complete in all respects. Therefore, if for any reason, the APARs are not complete, the same may be got completed before forwarding them to the undersigned. In case APAR of a candidate for a

certain period has not been written a certificate / letter of confirmation to that effect, indicating specific reasons may also be placed in the dossiers of such candidates.

4. As the final result of this examination has to be finalized expeditiously, you are requested to ensure that the requisite APARs are sent to the Commission by the aforesaid date. In case, the APAR dossiers of the candidates are not received within the stipulated date, the Commission will not consider the names of the concerned candidates for the compilation of the final result. In such a situation, the Commission would not be responsible for any consequences.
