**ORDER**

The approval of the Competent Authority is hereby conveyed for inclusion of Shri. Raj Kumar Sharma, Personal Assistant of Central Secretariat Stenographers Service (CSSS) in the Private Secretary Select List for the year 2001 against Seniority Quota, after having been found 'FIT' by the Departmental Promotion Committees (DPCs) in its meeting held in his Cadre Unit i.e. Ministry of Housing and Urban Affairs and clear from vigilance angle on the basis of the information received from the Ministry till date.

2. M/o Housing & Urban Affairs, where the officer has been approved for inclusion in PS SL 2001(SQ), is requested to notify the appointment of Shri Raj Kumar Sharma to the grade of Private Secretary of CSSS on regular basis after compliance of the following:

- (i) Civil Appeal No.629/2022 in Hon'ble Supreme Court of India and connected matters (Jarnail Singh batch of cases).
- (ii) Any other court case in connected matters.

A copy of the promotion order issued of the above officer may invariably be endorsed to this Department for record on the same day at **socs2a-dopt@nic.in** The cadre unit is also requested to furnish the information in this regard to this Department (CS-II Division) by **31.07.2022** positively in the enclosed proforma (**ANNEXURE**).
