## **OFFICE MEMORANDUM**

Subject: Supplementary zone of consideration for inclusion in **Select List of Section Officers' Grade of CSS for the year 2012 against Seniority Quota** - regarding

The undersigned is directed to refer to this Department's OMs of even number dated 06.02.2015 & 20.10.2015 and No.6/7/2015-CS-I(S) dated 24.08.2015, vide which the zone of consideration including extended zone of 60 persons for inclusion in the Select List for the year 2012 of Section Officers' Grade of CSS under Seniority Quota was issued.

- 2. The DPCs for assessment of officers included in the zone were held in the Cadre Units concerned and as per the information received from cadre units, 33 slots in SO SL 2012(SQ) remained unfilled in SO SL 2012(SQ) on account of cases of refusal/unfit/left service prior to the crucial date i.e. 01.07.2012 etc. as per details in **Annexure-I**. 2 slots were filled up vide zone of consideration issued vide OM dated 20.10.2015. Thus 31 (Gen-24, SC-04 and ST-03) vacancies remained to be filled in SO SL 2012(SQ).
- 3. Accordingly, a supplementary zone of 31 officers for inclusion in SO SL 2012(SQ) is enclosed as per **Annexure-II** to complete the size of the SO SL 2012(SQ). The cadre units concerned are requested to conduct DPC for consideration of these officers for inclusion in SO SL 2012(SQ) subject to vigilance clearance, fulfillment of eligibility conditions such as completion of 8 years of approved service as on 01.07.2012 and successful completion of mandatory Level B training programme or fall in the exempted category (58+ years) immediately and forward the DPC recommendations along with a copy of the minutes of DPC and vigilance clearance of the officer concerned to this Department compulsorily by 27.05.2022. This Department will issue orders for their inclusion in SO SL 2012(SQ) on receipt of recommendations of DPC.
- 4. This is issued subject to further orders that may be passed by Hon'ble SC in Jarnail Singh Batch of cases. The other terms and conditions will remain as contained in this Department's OM dated 06.02.2015.


