2. The other terms and conditions of promotion to the Sr.PPS grade on regular basis are same as contained in this Department's O.M. of even number dated 23.08.2022.

3. The Ministries/Departments shall ascertain the vigilance status of the concerned officer before assumption of charge/issuance of notification. In case of any discrepancies, relating to vigilance clearance of an officer, the same may be brought to the notice of this Department at the earliest.

4. The officers will be eligible for assumption of the charge w.e.f. 1st November, 2022. The notification for appointment issued by the concerned Ministries/Departments in respect of the officers as Sr.PPS on regular basis shall be subject to further orders that may be passed by the Hon'ble Supreme Court of India in the Jarnail Singh batch of cases (Civil Appeal No. 629 of 2022 arising out of SLP (C) No. 30621 of 2011).
