**ORDER**


A reference is invited to this Department Orders No.1/2/2020-CS.II(A) dated 14.12.2020 & 15.12.2020 and Orders No.3/6/2020-CS.II(A) dated 01.01.2021, 12.01.2021, 03.03.2021 & 16.03.2021 whereby promotions in the grades of Sr. PPS and PPS were made in CSSS on 'as is where is' basis.

2. The promotion orders (on as is where is basis), as mentioned above, of these officers has resulted in surplus of officers in various cadre units over and above the sanctioned strength. Continuance of the surplus staff in the cadre units over and above the sanctioned strength in a particular grade is not permissible and may lead to audit issues. Further, under the RTP guidelines, an officer at any level on promotion shall be posted out of the Cadre Unit/Ministry/Department, if he/she has served in the same Ministry/Department in any capacity for a period exceeding the prescribed tenure for the promotion post subject to certain exemptions as specified in OM No.25/28/2014-CS.II(A) dated 22.07.2015.

3. In pursuance to the above, it has been decided with the approval of the Competent Authority that the surplus officers whose names appear in Annexure of this Order are hereby transferred to the Ministry/Department indicated against their names with immediate effect.

4. Ministry/Department concerned are requested to ensure that the officers comply with the transfer order strictly. A copy of the order may be served to the officers concerned for their information and compliance.
